## 2. Third Party Websites, Plug-ins and Applications.

#### 3. Personal Information We Collect.

Personal Information means information about you that is provided to us that could reasonably be used to identify you. Personal Information includes "Protected Health Information" as defined in the Health Insurance Portability and Accountability Act (HIPAA). It does not include information or data where your identity has been removed or anonymous data.

When you visit our Website, we collect the following personal information about you:

• Unique identifiers and preference information such as your pages visited, internet protocol (IP) address, browser type, operating system or host, computer or mobile device, country of origin and your navigation and clickstream behavior from actions that you take on our Website or through a Service. We may share this information with our service providers for the purposes set forth in this Privacy Policy.

- Information about you from affiliates, subsidiaries, marketing partners, ad networks, and other third parties. We may combine this with information we already have about you.
- Information about you that you share or make visible on the Internet. We may combine such information with information we already have about you.

When you create an account or subscribe to a Service, you will be asked to submit some or all of the following Personal Information to verify your identity and establish an account:

- Name, home or other physical address, email address, phone number, social security number, fax number date of birth and NPI number. For Organization Certificates, the applying entity will also be required to provide its name, EIN number, NPI number, address, URL to which the Organizational Certificate is to be issued, and the name of an administrator for such organization, including the administrator's name, physical address, email address, phone number and fax number. This information is used by MaxMD to verify your identity, completing the registration process and creating your account.
- Payment information, such as your credit card number. MaxMD stores and uses this payment information to process payment for your subscription to the Service as well as processing payment for automatic renewals of your subscription.
- A Service may also allow you to securely exchange protected health information as described in Section 5 below.
- If you create a .domain registration account, you will be required to provide (a) the registrant or legal owner of the domain, (b) an administrative contact responsible for matters regarding maintenance and servicing of the domain, (c) a technical contact, and (d) billing contact. For each of the foregoing, we collect the legal or organizational name, street address, phone number, fax number and email address.

We also collect, use and share aggregated data such as statistical or demographic data for any purpose. Such aggregated data does not directly or indirectly reveal your identity. For example, and not by way of limitation, we may aggregate certain data about how you use the Website or a Service to calculate the percentage of users accessing a specific Website or Service feature or function. However, if we combine or connect aggregated data with your personal information so that it can directly or indirectly identify you, we treat the combined data as personal information to be used in accordance with this Privacy Policy.

We do not collect any special categories of personal information that include details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, or trade union membership, information. If you fail to provide personal information where we need to collect personal information by law or under the terms of a contract we have with you, and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you. For example, and not by way of limitation, we may use such personal information to provide the

Service to you. In such cases, we may have to cancel the Service you have with us, but we will notify you if this is the case at the time.

#### 4. Methods Used to Collect Information.

We use various methods and technologies to collect personal information about visitors to the Website and subscribers to or users of a Service. These methods and technologies include the following:

## 5. Security and Health Insurance Portability and Accountability Act ("HIPAA").

Such information is automatically encrypted when it is transmitted. Such information is also securely stored by the Service in our private cloud at secure facilities in the United States until you delete it from the Service, or the Service is terminated.

If you chose to use the MaxMD Mobile Application in connection with the MaxMD Direct Secure Messaging Service, you can retrieve and view your protected health information on your supported device and this information will be stored on your supported device. The MaxMD Mobile Application requires a pin or biometric lock on the supported device in order for the user to use and view data in the MaxMD Mobile Application. If you chose to view or download your records to your supported device or a third-party application, such as a DropBox® account, MaxMD is no longer responsible for the security of such information. Data on your local device is subject to the security measures that you have enabled on your device.

You should consult your personal Supported Device, third party application or security software provider for more information as to how to best protect such information.

Please be aware that no data transmission over the Internet can be guaranteed to be 100% secure and this is not a guarantee that your personal information (including protected health information) will not be accessed, disclosed, altered or destroyed by breach of any physical and technical safeguards in place. All information you transmit on or through the Website and Service is at your sole risk.

You are responsible for maintaining the secrecy of your unique password(s) and account information, and for controlling access to your account(s) at all times.

#### 6. How We Use the Personal Information Collected.

We may use your personal information collected for the following purposes:

- To communicate with you regarding updates to the Service and Website and to respond to your inquiries, requests and applications and/or to send important notices. To conduct surveys and research. To create your Website or Service account and allow use of the Service.
- To better understand how the Service and Website are being used and to improve the Service and Website.
- To provide personalized Website and Service content based on your activity and preferences.
- To communicate with you regarding updates to the Service and Website and to respond to your inquiries, requests and applications and to send important notices.
- To conduct surveys and research.
  - o If you participate in surveys, we will request certain personal information from you. Participation in these surveys is completely voluntary and you therefore have a choice whether or not to disclose this information. We may use a third-party Service Provider to conduct these surveys. We will not share the personal information you provide through a survey with other third parties unless we give you prior notice and choice.
- To further develop our products and services and to improve our business.
- To track your use of the Website and Service as reasonably necessary to prevent illegal activities and to enforce our Terms of Use and Authorized User Agreement.
- We may also send you emails with information about MaxMD products and services that we believe may be of interest to you. If you wish to opt-out of receiving these emails from us, please follow the instructions contained in that email.

#### 7. How We Share Personal Information Collected.

We do not sell or rent personal information or protected health information we collect through the Website or Service to any third party for its own marketing purposes. We will

# get your express consent before we share your personal information with a third party for their own marketing purposes.

We may share your personal information as follows:

- We may disclose your personal information to our Service Providers who provide certain services to us or on our behalf, such as operating, providing and supporting the Service, analyzing data, verifying your identity, processing payments or performing marketing or consulting services. These Service Providers will only have access to the personal information needed to perform these functions on our behalf.
- If you sign up for a domain registration, we will share the information outlined in Section 3 above with NIC.MD STISC for purposes of establishing your domain registration. For information about how STISC uses this information, please refer to their privacy practices.
- Some of our pages use framing techniques to serve content to or from third parties while preserving the look and feel of our Website or the Service. Please be aware that you are providing personal information to these third parties and not directly to MaxMD.
- Our Website may offer a publicly accessible blog. You should be aware that any personal information you provide in these areas may be read, collected and used by others who access them. - We may also disclose personal information about visitors to our Website or users of the Service as follows:
  - o As required by law, such as to comply with a subpoena or similar legal process.
  - When we believe in good faith that disclosure is necessary to protect our rights or property, protect your health and safety or the health and safety of others, or to investigate illegal activity or fraud or to respond to a government request.
  - o In the event of a merger, acquisition, asset sale or in the unlikely event of bankruptcy, personal information (and protected health information) maintained by or on behalf of MaxMD may be transferred to its successors or assigns.
  - o To any other third party with your prior consent.
  - We may also share information relating to users of the Website or Service with affiliated or unaffiliated third parties on an anonymous, aggregate basis. While this information will not identify you personally, in some instances these third parties may be able to combine this aggregate information with other data they have about you, or that they receive from third parties, in a manner that allows them to identify you personally.

These disclosures will be accurately recorded. The accounting of disclosures will be recorded and retained, as applicable by law, and made available to you upon request.

## 8. Children's Privacy.

Children under the age of 18 are not permitted to create an account or use the Service, and we do not knowingly collect personal information from children under 13 years of age, except personal information and protected health information sent, received, transmitted or stored through the Service by a parent or legal guardian who is authorized to do so. ## 9. Special Notice for Users Located Outside the United States.

The Website and Service are currently provided from the United State for use by persons in the United States. Many of our third-party service providers are also based outside the European Economic Area (EEA). Their or our processing of your personal information will involve a transfer of your personal data outside the EEA. ## 10. Accessing, Changing and Managing Your Personal Information.

The Website and/or Service may allow you to directly view, edit or delete personal information about you online. ## 11. Data Security.

We have put in place appropriate security measures designed to prevent your personal data from being accidentally lost, used or accessed in an unauthorized way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data to perform services on your behalf and they are subject to a duty of confidentiality.

MaxMD encourages a culture of compliance and vigilance and that all employees shall cooperate with any internal or external investigations related to the handling of your personal information. MaxMD shall ensure that no acts of intimidation or retaliatory action take place against an individual who may submit a complaint or participate in an investigation or other enforcement activities. If a MaxMD employee has reason to believe that company representative(s) are not adhering to the provisions of this policy, an employee should contact the company Data Protection Officer.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

#### 12. Data Retention.

We will only retain your personal information for as long as necessary to fulfil the purposes we collected it for, including but not limited to, for the purposes of satisfying any legal, accounting, or reporting requirements.

To determine the appropriate retention period for personal information, we consider the amount, nature, and sensitivity of the personal information, the potential risk of harm from unauthorized use or disclosure of your personal information, the purposes for which we process your personal information and whether we can achieve those purposes through other means, as well as applicable legal requirements.

The MaxMD Data Protection Officer periodically consults with senior management to ensure that the required accountings of disclosures of records are being properly maintained and provided to the persons named in those records.

By law, we have to keep basic information about our customers (including contact, identity, financial and transaction data) for six years after they cease being customers for tax purposes.

For legal and audit purposes, we currently keep log data for up to eight (8) years.

In some circumstances you can ask us to delete your data. See request erasure below for further information.

#### 13. Your Legal Rights.

Under certain circumstances, you may have rights under data protection laws in relation to your personal information. These rights may include the following:

## • Request access to your personal information.

You may request a copy of the personal information we retain. You may also request the categories of personal information we retain about you. Upon request we will provide you with the data in a commonly used and machine-readable format.

## • Request correction of your personal information.

 You may correct any personal information we retain about you if it is incorrect or incomplete.

## • Request erasure of your personal information.

You may ask us to delete your personal information if there is no good reason for us to continue to retain it. You also may ask us to delete personal information in instances where (a) if you have successfully exercised your right to object to our processing of such personal information, (b) if we processed or are processing such personal information in violation of applicable law, or (c) if we are required to erase your personal information by law. We will destroy, erase, dispose, sanitize or anonymize your personal information in a manner which prevents it from being lost, stolen, misused or accessed without authorization once the personal information is no longer needed for the stated purposes for which it was collected and/or at the end of the applicable legally required retention period. However, we may not always be able to comply with your request due to legal or technological reasons. If this is the case, we will notify you at the time you request deletion of your personal information.

## • Object to processing of your personal information.

You may object to our processing of your personal information if we are using it for marketing purposes. You may also object to our processing of your personal information in instances where we are relying upon our, or a third party's, interests to process your personal information, if you believe it impacts your fundamental rights or freedoms. Where possible and practical, we will provide you with the ability to object to specific aspects of the PII processing.

#### • Request restriction of processing your personal data.

You may request that we suspend processing of your personal information if (a) you need it to defend, establish or exercise legal claims, (b) we need to verify our legitimate right to use your personal information in an instance where you have requested we stop processing it, (c) our processing of such personal information is unlawful but you do not want us to erase it, or (d) you want us to establish the personal information's accuracy.

## • Request transfer of your personal data.

o If you request us to transfer personal information you provide to us in an automated manner or to perform a contract with you, we will use commercially reasonable efforts to provide this information to a third party in a machine-readable format.

## • Right to withdraw consent.

 You have the right to withdraw your consent to our processing of your personal information if we are relying upon your consent to process such information. This will not affect any processing of such personal information before you withdraw your consent. If you withdraw your consent, we may not be able to provide you with a product or service for which you have subscribed. If this is the case, we will notify you at the time you withdraw your consent.

## NO FEE USUALLY REQUIRED

You will not have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request is clearly unfounded, repetitive or excessive. Alternatively, we may refuse to comply with your request in these circumstances.

#### WHAT WE MAY NEED FROM YOU

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal information (or to exercise any of your other rights). This is a security measure to ensure that personal information is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.

#### TIME LIMIT TO RESPOND

We try to respond to all legitimate requests within one month. Occasionally it may take us longer than a month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.

## 14. Changes to Privacy Policy.

We reserve the right to change or amend this Privacy Policy at any time. If we make a change, we will post the revised Privacy Policy on the Website and revise the "Last Updated Date" at the top of this Privacy Policy. If you have provided us with your email address, we will also notify you by email of material changes to this Privacy Policy by sending an email to the email address we have on file prior to the effective date of the changes. We will use commercially reasonable efforts to notify you of any changes to this Privacy Policy by email at least fifteen (15) days before the effective date of the changes. We will also provide a notification to registered users the next time they login to any Service with the revised Privacy Policy and users will be asked to acknowledge that they have read and accept the changes by clicking "I Accept." Your continued use of the Website or any Service following the posting of changes to this Privacy Policy means you accept those changes. Any amendment or change to this Privacy Policy will not apply to any dispute that we had actual notice of prior to the effective date of the amendment or change. MaxMD will conduct periodic reviews of this privacy policy to ensure that PII which is collected is necessary to accomplish our business purposes.
